### **c. 2025 HOUSING CAPITAL FUND DEBRIEF**

Dorsol Plants provided a brief update on the outcome of the 2025 Housing Capital Fund funding round and not reallocating the previously awarded funds from the Pandion at Star Lake project to the 2025 round.

#### **d. 2026 EDUCATION AND ENGAGEMENT OPPORTUNITIES**

Dorsol Plants discussed Action Item 12 from the 2026 SKHHP Work Plan and opportunities for the Advisory Board to engage with the community or elected officials.

The Board discussed general ideas, and there was a consensus that Dorsol Plants should connect with SKHHP's community partners to provide the Board with clear opportunities to engage that are effective and do not take away from the primary focus of ensuring homes are built in the community.
